The Board approved the January 2018 minutes. The Board also approved the February 2018 minutes for distribution. The Financials of 2.28.2018 were also approved.

In the Management Report it was agreed to seek a bid for a garage door replacement. Manager Bonde explained the frost investigations and repairs at 3663 Denmark and 1296 Crestridge. The Board approved obtaining bids for Association-wide gutter cleaning. Bonde placed a work order to the USPS for repair of leaning mailbox.

In preparation for driveway replacements west of Denmark Avenue, a current visual assessment of the condition of stoops and aprons needs to be conducted after the snow melts. The number of these to be replaced prior to the driveway replacements needs to be determined, priced and completed prior to any driveway work.

In Old Business the Board continued review of the Maintenance section of the proposed Declarations update.

In New Business the Board reviewed the Roofing Evaluation conducted October 2017 by Hoyt Exteriors. This report provides written and photo definitions of damage conditions. It also reports the condition of each of the 43 buildings. Besides providing a baseline assessment of the roof conditions, it indicates areas to be attended to when the weather permits. The Board approved Hoyt Exteriors to complete repair of the immediate problems of which the Association is responsible when the weather permits.

The meeting was adjourned at 8.22 p.m.
