The June minutes and financials were approved as distributed. In the Management Report the Board denied the request for the unapproved partition that was built with the deck at 3637 Denmark. The homeowner will have ten days to remove the partition upon notice. The tree trimming requests from 1223 TS and 3656 KR will be added to the list. The Board approved reimbursement for A/C removal at 1180 TS since the homeowner paid for removal when the walk/step and a/c pad were replaced. The stoop is now being replaced. This follows precedent.

Sixteen stoop replacement letters were sent. Most of the landscape trimming request letters resulting from the spring walk around have been sent. The last six old style garage doors notices have been sent. Turning Leaf will begin the approved landscaping projects in July. A letter will be sent to the affected homeowners prior to work commencing to instruct them to the watering procedures.

No Old Business. Under New Business the engineer's report regarding the east boundary was finally received. Four landscaping companies have been contacted to inquire of their interest. Bids will be sent out to those interested. The Board approved bids from Roggenbuck for trimming identified trees (4793.84 with tax) plus those he identified with limbs touching or close to the building (\$1553.31 with tax) for a total of \$6,347.15

The meeting was adjourned at 6:00 p.m.
