Meeting Called to Order by President Halverson at 5:03 pm. Board members present: Goodman, Halverson, Iseminger, Lamusga, McDuff, Tippins and Walker. Networks Management, Ben Bonde present. The Board approved the minutes from the regular and executive meetings in May as corrected. The Board approved the May 31, 2021, financials as presented.

In the Management Report the Board approved two tree removals and replacements at 3652/3654 KR. Bonde reported that the chimney case tuck pointing at 1214 TL is complete. Flue repair is the homeowner responsibility. Tree suckers at 3658 KR were referred to Roggenbuck. The Board acknowledged the landscaping alteration at 1206 TL which was within the approved request. Bonde reported that a rusted railing at 1201 TL has been ordered. The landscaping requests from 1180 and 1259 TL will be added to the list for future improvements. The Board approved patio door replacement requests for 1182 and 1277 TL. The Board approved asking C & D Yard and Landscaping Services to add soil and sod at 3691 DM when they conduct the approved gutter drainage pop-up work. The homeowner will be required to water the sod as prescribed.

Bonde noted that he sent several fine letters in follow up to the annual walk about inspection. The Phase 3 driveway project is projected to start July 12,2021. The roof inspection by the insurance engineers is expected soon.

In Old Business the Board selected a design for house number replacement. They also selected two background colors. Bonde will request a bid. In New Business the Board will meet again at Networks building on July 8, 2021. Meeting Adjourned at 5:55 pm.
