## **Monthly Meeting**

The Board of Directors meeting was called to order at 5:00 pm by President Halverson. Members present: Nancy Goodman, Lori Halverson, Dick Lamusga, Paulette Tippins, Kelly McDuff and Linda Walker. Ben Bonde represented Network Management.

The Board approved the October Minutes and Financials as submitted. In the Management Report the Board heard about a homeowner's request to waive fees for outside garbage cart storage. Garbage cart rules are enforced as defined. Gutter cleaning scheduled for mid-November. The 2<sup>nd</sup> fall cleanup will take place this week or next depending on weather. 1240 TL needed a gutter repair that involved rebuilding fascia behind gutter. Scheduled stoop replacements are delayed until spring because the weather has turned too cold. Fast Signs in process of installing new address plaques. Thank you to Linda, Dick and Nancy for checking outside water faucets for winterization.

In New Business the Board reviewed insurance quotes. Motion approved to change HOA insurance to General Star Indemnity. This will be effective 12/1 rather than 2/1, which it has been for a number of years. This new renewal date will align better with budget planning. Ben will send out the new policy information when ready. The HOA will have a financial review completed at year end.

The Board approved the 2022 budget with a \$12 increase to \$270/month. The majority of this increase goes towards insurance. The HOA industry experienced increased rates everywhere. Other increases were made to match rising prices. A budget comparison will be sent to all homeowners with more detail.

Meeting adjourned at  $5:50\ pm$ . The next meeting is January  $13^{th}$ , 2022.
